# **Superintendent's Notes**

I recently administered a survey of all parents in our district in an attempt to determine the level of parent satisfaction in our schools. Another goal of this activity was to identify opportunities to make our district even better for our children, parents, and community.

I am pleased to share the following percentages of parents who indicate that they are highly satisfied with our schools:

- \* Walton-Verona Elementary School: 91.7% of 60 total responses
- \* Walton Verona Middle School: 77.8% of 53 total responses
- \* Walton-Verona High School: 89.3% of 74 total responses

In addition to the impressive data above, I would like to share some individual parent comments about our schools: Walton-Verona Elementary School:

- \* My child has been supported academically and emotionally her entire WV career. She feels safe. She feels loved. She is challenged academically and provided opportunities to grow personally.
- \* The teachers have been great at communicating expectations, and sending appropriate work home. The work my son brings home daily that he is doing in class is very appropriate for his age.
- \* Caring and communicative teacher, interactive lessons, hands on activities that are engaging.

Walton Verona Middle School:

- \* The teachers support and push the kids to grow as independent thinkers.
- \* We moved in from another district recently and we're happier with WV than we've been in years.
- \* I believe that Walton-Verona schools do their best to help our children with their education along with parental involvement.
- \* The entire staff is dedicated to the success of my daughter.

Walton-Verona High School:

- \* We moved to Walton for the school district 2 years ago and have not been disappointed.
- \* Walton-Verona has so many opportunities for our children to excel in many areas.
- \* I believe my child is not only educated by our faculty and staff, but he's also nurtured and encouraged by them! We truly have some top notch educators!
- \* My child is challenged in a positive way by the courses available; great opportunities with extra-curricular activities.
- \* Teachers are always willing to go the extra mile to make sure my kids have an adequate chance to learn the material even if it means after school help, retaking tests at times, etc.

After reading these and many other comments from our parents, it is easy to understand why our district is a "district of choice" in Northern Kentucky. # When Being Considered an "Other" is a Good Thing!

This fall, the WVES Bearcats eagerly awaited the 2018 KPREP results from the spring. They came in early October of this year, and to our delight (but not surprise), our 3rd and 4th graders performed very well. I was extremely excited to share the good news as soon as possible.

When the scores come in, however there is a bit of an "embargo period" where schools are told they need to keep all state assessment information confidential until released from the embargo. It was during this time period our administrative team had a chance to dive into our data for an early peak at how our kids did.

While doing this early investigation, we were also undergoing a little self-teaching of how to interpret the new Kentucky Assessment System which had just been revamped to include several new parts designed to make the data more clear and easier to communicate to parents and community. Essentially, the opposite effect was true.

While the kids still achieve the ratings of "Novice, Apprentice, Proficient or Distinguished" in elementary reading and math, many of the other working parts of the assessment system changed.

Within the system, students are also rated on the growth made from one year to the next. This system, which took nearly 4 years to create, produced a growth rating which is definitely not easy to explain and is frankly, a little funny to say. Based on a student's score over a 2 year period, he/she is labeled as "catching up, keeping up or moving up." If the student is doing poorly and not on track to make it to proficiency, then he/she is considered "less than catch up." One popular humorist in Kentucky holds up a little packet of ketchup as he explains this in a video.

On top of this ridiculous component, Kentucky schools are placed into rating categories since the assessment creators and the Kentucky Department of Education abandoned the idea of ranking schools. The 3 categories are "CSI" (comprehensive support for improvement), "TSI" (targeted support for improvement) and "Other." The first two categories indicate the school is performing poorly enough in an area or two or with a particular sub group (minorities, genders, free/reduced lunch status, English learners etc.) to get the attention of the Department of Education. If a school gets one of these two labels, the school is treated to creating extra improvement plans for and will ultimately be receiving extra monitoring or "support" from the Department of Education. Needless to say, we do not want to be "TSI" or "CSI." Incidentally many, many schools in Kentucky were put into one of these categories.

This leads back to the title of this article. In a lot of cases, being labeled an "Other" in systems where a school is awarded titles or trying to describe how well an entity had performed on some task, the term "Other" may not necessarily sound like a good thing. However, in the new Kentucky Assessment System, it is just that.

And this is exactly what Walton-Verona Elementary (and our other two campus schools) were able to achieve this testing cycle. We had an excellent rate of proficiency in 3rd and 4th grade reading and math. We scored at a 65.2% proficient/distinguished rate for 3rd grade reading and 61.3% for 4th grade. 3rd grade scored at a 48.6% proficient rate in math and 4th grade was at 57.2%. All of our subject level scores outperformed the state average. What's more, all of demographic groups such as minorities, genders, free/reduced lunch status and students with disabilities all out-performed last year's marks for proficiency and helped us elude the cut off scores which might have placed us in a "TSI" or "CSI" category.

Philosophically, I do not disagree with the notion of students taking a state test. I think assessments whether given during the year or near the end can and do give us valuable information about students with which we can make generalizations about our practices as a school. What I don't like is that the KPREP test is a snapshot from a few days in May around which so much importance is placed. This one test, can make or break a school from a managerial standpoint. This is the one test the community and press know the most about. However, it is probably the one that gives us the least information and is definitely the least timely (in terms of when we get the data and how quickly we can use it). By the time we get the 2018 Spring scores, one of our two grade levels that took that test has since departed for our middle school. The KPREP is also one that comes with enormous built-in pressure frankly, we as a school, community and state, place upon our students. This can weigh heavily on a child who is 8, 9, or 10 and may not yield results from particular students one might expect.

Overall, I was proud (to put it mildly) in our first year under the new system, we were able to attain the coveted title of "OTHER." Our teachers work tirelessly with kids to get them prepared for the next grade level coming up and the natural by-product of that work is the preparation for the state assessment. The kids did a fantastic job of taking this task seriously over the course of almost an entire week in the month of May (when many of them are thinking more about summer break than taking a test). They really rose to the occasion, so to speak. I think everyone realizes students should do their best on the test since testing is part of simply being a good school citizen. But at the end of the day, it is more about the day to day progress one makes (which can be assessed by a skilled teacher) than an end-of-the-year state autopsy report that comes in late.

# **Public Notice**

#### Asbestos Management Plan for Walton-Verona Schools

This notice is being issued to insure that you know that the Walton-Verona Board of Education is in compliance with both national and state regulations and laws that relate to building materials which contain asbestos that have been used in building construction in past years.

An inspection for building materials which contain asbestos has been completed for all buildings owned by Walton-Verona Board of Education. This inspection has been conducted by a certified inspector and the material samples were evaluated by an accredited laboratory. Building materials with as little asbestos as one percent (1%) have been identified and made part of a management plan for the school system.

A complete asbestos management plan for the school system is on file at the Walton-Verona Board of Education office. Also, a copy of the asbestos management plan for each individual school is on file in each building principal's office.

We will continue to notify you at least once each year on the status of the management plan. Should it be necessary, more frequent updates will be issued as a result of an additional inspection, normal surveillance practices, response actions, or remodel work which might disturb building material which contain asbestos. Every precaution will continue to be used to protect the well-being of students and employees of the Walton-Verona Schools.

The last week of September, the Kentucky Department of Education released the 2017-18 test scores. As in years past, the information has always been available to stakeholders by viewing the state generated school report card. The school report cards will not be released on the Kentucky Department of Education website until sometime in December. Until the school report card is available for public view, I wanted to share with you a snapshot of our state testing results.

We are currently in year two of transitional testing data. There are many pieces of the state accountability data that are changing, so comparison of data year to year is difficult, but we are proud to showcase the results.

The percentage of our junior class who met proficient or distinguished benchmarks on the ACT exceeded the state average on all subjects of the ACT. Since 2014-15 the percentage of juniors meeting or exceeding English and Reading benchmarks shows positive linear growth. Based on the junior ACT administered in March of 2018, our juniors' composite average was a 22.06. This same class had a composite ACT average of 19.68 on their sophomore Mock ACT given in March the previous year. This speaks volumes of the academic programs our students are receiving and the extra help sessions the students are taking advantage of during seminar time. Walton-Verona High school currently ranks thirteenth in the state of Kentucky for our juniors' performance on the ACT and our district ranking for this same score places us at sixth in the state of Kentucky.

Other areas of strength were the juniors' performance on the On-Demand Writing assessment, with 26% of the junior class earning a distinguished score and 40.9% of the junior class earning a score of proficiency.

The area of accountability for our senior class focuses on two areas: Transition Readiness and Graduation Rate. The Class of 2018 showcased a College Readiness rate of 63.1% and a Career Readiness rating of 63.8%. The graduation rate for the Class of 2018 was 99.2%, one of the highest rates we have seen in the past five years, We are proud of the efforts of our staff and students to help the Class of 2018 with their transition to college or the work place.

This year the state ratings for schools took a shift with the categories of CSI (Comprehensive Support and Improvement – the bottom 5% of performing schools), TSI (Targeted Support and Improvement – for schools where gap groups did not meet proficiency standards) and "Other." We are very excited that our student performance indicators have classified us as an "Other" school. The teachers at Walton-Verona High School have been working with the data from all areas of accountability to see how we can improve and continue to earn high marks with the state testing accountability.

One area to showcase not reflected in our school report card, is the number of students we have participating in our dual credit program. Juniors and Seniors who meet specific criteria are given the option to take some of their courses at the college level. Some of these courses are offered at our school, while some students are seeking out opportunities at other college campuses. This year we have students taking courses through Northern Kentucky University, Kentucky State University, Murray State University and Gateway Community College. The courses being taken this year are as follows: Speech, Spanish 101, Spanish 102, Spanish 201, Spanish 202, Vet Sciences, College Algebra, Composition, Advanced Composition and numerous CTE dual credit courses including electrical, circuits, automotive, welding and healthcare. Students who qualify for the dual enrollment program are charged only \$168 for the three hour course. That is a huge savings for our students, as taking one college level course typically exceeds \$1200 at the university level. For this current year, we have 116 students taking 255 college classes. Given the enrollment numbers above, that represents

Outside of the classroom our students have many opportunities to participate in sports and club activities. Our sports teams continue to stay competitive at all levels and our clubs are involved in many service projects and competitions as well. I will always encourage high school students to get involved in something outside of the school day in their area of interest. Involvement in extra-curricular activities always enhances a student's high school experience.
